### ***CLE Programming***

At this year's Annual Meeting, HIS presented an entire afternoon of timely and relevant CLE programming. Thanks to all that attended! If you were not able to make it, here is what you missed:

#### ***Labor/Employment Law: Warning for Non-Union Employers (Large or Small) –The NLRB May be Watching You***

*Speakers:* Michelle Alcala, Graves Dougherty Hearon & Moody, P.C.

Ms. Alcala discussed the National Labor Relations Board's recent investigative scrutiny of union and non-union employers' personnel policies and provisions in employee handbooks. Provisions that appear to incur on the right of an employee to talk about wages and working conditions will likely be declared by NLRB as unlawful and a violation of the employee Section 7 rights, including the right to engage in concerted activity relating to the workplace.

#### ***Immigration Consequences of Criminal Offenses***

Novert Morales, Austin, Morales Law Office Attorneys At Law, PLLC, Austin, Texas

Mr. Morales and Ms. Pollack discussed the practical aspects of representing non-citizen criminal defendants following the U.S. Supreme Court's holding in *Padilla v. Kentucky* (2010) that defense counsel must advise their non-citizen clients of the immigration consequences of a plea.

#### ***Notario Fraud: Unauthorized Practice of Law and Potential Private Causes of Action***

The panel, moderated by our own Past Chair Manuel Escobar, discussed notario fraud, the Texas Attorney General's Office, the Texas Supreme Court Unauthorized Practice of Law Committee, and other groups' efforts to combat and prosecute notario

fraud, and the evolution of a potential private cause of action under the Texas Deceptive Trade Practices Act. The panel also discussed HIS' multi-year Notario Fraud project and the need for volunteers.

HIS also co-hosted a Diversity Forum with the African American Lawyers, Asian Pacific Interest, LGBT Law and Women in the Law Sections.

***Reception and Awards***

The CLE was followed by a joint reception co-hosted by HIS and the Asian-Pacific Interest Sections, at which HIS gave out its annual awards!

***HIS Annual Awards***

HIS honors members of the Hispanic legal community at its annual meeting through a number of achievement awards. The recipients honored at the HIS annual meeting in 2016 are the following individuals and entities, who represent the best of our profession.

***Bar/Organization of the Year: Hispanic Bar Association of Houston***

Since its inception in 1988, the Hispanic Bar Association of Houston ("HisBa") has represented and promoted the growing impact of Hispanics in the practice of law and the community at large; it is a leading voice in the Houston legal community. But, what has most distinguished HisBa from other bar associations is its development of leaders through financial scholarships. Every year, HisBa holds a "Presidents Day Gala"; the sole objective is to raise scholarship monies. Last year, HisBa awarded close to \$40,000 in scholarships to high school students ("Scholarships for Excellence"), and to first- and second-year law students, and Bar Review scholarships to third-year law students. The impact of these scholarships cannot be underestimated.

***Judge of the Year: Justice Dori C. Garza***

Justice Garza has "demonstrated passion for the law, commitment to the practice, and, leadership skills throughout her career." A graduate of the University of Texas and the University of Houston Law Center, she is originally from the Lower Rio Grande Valley. After a distinguished law practice that took her from Houston to San Antonio and then back to the Valley, she was elected to the 13th Court of Appeals in 2002, and is currently a candidate for the Texas Supreme Court. She's a past President of the Hidalgo County Bar Association, and was recently recognized as a Woman of Distinction by the Rio Grande Valley Hispanic Chamber of Commerce and also received the Good Samaritan Award from the Good Samaritan Community Services.

## ***James W. Wray Jr. Founder's Award: Judge Debra Ibarra Mayfield***

A native Houstonian, Judge Mayfield is a graduate of Texas A&M University and South Texas College of Law. In her “young” legal career, which she began as a briefing attorney for the 14th Court of Appeals, she has received two judicial appointments. The first, to the Harris County Civil Court at Law No.1, was historic; she is the first Latina either appointed or elected to a county court at law bench in Harris County. Approximately 4 years after her initial appointment, Governor Greg Abbott appointed her to the 165th Civil District Court of Harris County. Her recognitions to date include: “Woman on the Move” by Texas Executive Women, the “Public Service Award” from South Texas College of Law, the “Top Latina 40 and Under” from the Mexican American Bar Association of Texas Foundation, “Amicus Award” by the Mexican American Bar Association of Houston (of which she is a former President), and, most recently, the “Outstanding Mentor Award” from the Houston Young Lawyers Association. She is an active HIS board member.

## ***Legislator of the Year: State Representative Mary Gonzalez***

This native of Clint, Texas was first elected to the Texas State House of Representatives in 2012. She was immediately recognized as “Freshman of the Year” by the Mexican American Legislative Caucus. In her current tenure, she has authored bills to improve public schools, increase economic development and support agriculture. She received her undergraduate degree from UT Austin and her Master's Degree from St. Edwards University, and is currently pursuing a Ph.D. at UT Austin in Curriculum Instruction-Cultural Studies Education. Still young in her career, she has been named one of ten “Next Generation Latinas” by Latina Magazine, one of the “10 newly-elected politicians to watch in the nation” by NBC Latino and was recognized by Latino Leaders Magazine for her leadership in education. She's also the youngest inductee into the El Paso Women's Hall of Fame.

## ***Pete Torres Public Service Award: Frank Herrera, Jr.***

Frank Herrera Jr. is a Valley native-born and raised in Edna, Texas. He obtained both his undergraduate and law school degrees from St. Mary's University and remained in San Antonio after completing his education. He has been a licensed attorney for 48 years. Frank is “seen as a leader in the courtroom and is sought out by attorneys across the country for his expertise in different areas.” Frank was a strong advocate for economic and political empowerment for the Latino community. He still regularly volunteers his time, energy and financial resources to social causes. His community involvement, accolades and awards are too numerous to identify but include recipient of the prestigious OHTLI Award from the Mexican Government, Recipient of the Pat Maloney Award, Board of Directors of MALDEF, Hispanic Business Magazines 100 Most Influential Leaders, and Hispanic Heritage Award for the Legal Profession.

George B. Hernandez Jr., a native of San Antonio, Texas, is an alum from St. Mary's University and George Washington University School of Law; he has been a licensed attorney for 39 years. During those 39 years, he has distinguished himself in not only the legal field, but also in the medical and healthcare fields. Mr. Hernandez began his legal career as an Assistant City Attorney in San Antonio, then worked as Chief of the Civil Section at the Bexar County District Attorney's Office. He then moved on to the Bexar County Hospital District, where he was the first-ever Vice President (General Counsel) of Legal Services. ## Update on Notario Fraud Issue

Last year, we announced a multiple-year notario fraud project intended to get our Section educated and involved in the fight against notario fraud across the state. Little did we know how daunting the project truly would be, and we spent a significant amount of time simply gathering information on what materials and programs already existed. We determined that the best way to move forward was to convene a planning group consisting of stakeholders representing groups that interact with notario fraud victims at all stages – including those specifically prosecuting notario fraud such as the Texas Attorney General's Office and the Unauthorized Practice of Law Committee, nonprofit organizations, advocacy groups, consulates, legal aid providers, immigration and other private practitioners, and others.

In early September in Houston, we had the first meeting of such a planning group, organized by the Houston Immigration Legal Services Collaborative. We had over 25 people in attendance who collectively represent the capacity to reach millions of people in communities and, over the course of two hours, we discussed the notario fraud problem, how the attendees saw notario fraud affecting the people they serve, and some of their ideas about what actions and resources would be most helpful, both now and in the future. We plan to meet again in a couple of months and to have further discussions in the interim, and we are in the process of developing subcommittees that will begin doing the hard work of actually putting together resources and programs.

We will continue to seek out anyone with an interest in participating – please contact me ([mescobar@mcginnislaw.com](mailto:mescobar@mcginnislaw.com)) if you would like to help, or if you know of someone with whom we should be speaking.

Our plan is to continue to meet with the stakeholder planning group in Houston and to start our efforts there, both because of the availability of a large number of stakeholders and because of the likely larger size of the notario fraud problem there. As we begin developing resources and programs, we hope to spread those to other cities as well.

This will take time. But your Section and your Executive Committee are fully committed to being involved in this project for as long as it takes. And we believe the initial meeting was extremely encouraging. We look forward to sharing more with you in the coming months!

## SBOT SUNSET REVIEW

### **Legislative Update: Sunset Review of the State Bar of Texas and the Board of Law Examiners** *by Gloria Leal, Attorney at Law & Legislative Consultant*

The Sunset Advisory Commission of Texas met on August 22, 2016 to vote on recommendations from Sunset Commission staff regarding continuation of various agencies including the State Bar of Texas. Chaired by State Rep. Larry Gonzales (R-Georgetown) and Vice-Chaired by Senator Van Taylor (R-Plano), the Commission composed of four senators, four state representatives, and two public members, voted to continue the two agencies for 12 years, approved updates to the attorney's disciplinary process as recommended by staff, established an independent Ombudsman Office and voted to retain the referendum rulemaking process. Sunset Staff made no dramatic recommendations to reorganize the State Bar. Staff found the quasi state agency generally to be a well-functioning organization albeit with an archaic rulemaking process requiring attorneys to approve any changes to rules through referendum which in the past has tended to politicize issues and not resulted in any changes. The staff recommended replacing the referendum requirement with a more standard rulemaking process under the existing authority of the Supreme Court, which proposal was rejected by the legislative panel. In addition, staff identified significant concerns with the current attorney disciplinary process and recommended investigative tools and best practices to improve efficiency in governing the conduct of attorneys. The approved recommendations for the State Bar will be incorporated into legislation to be drafted and filed in time for consideration during the next Legislative session scheduled to convene January 10, 2017. The sunset legislation will be considered by the full membership of the House and Senate before becoming law. The following are **some of** the specific issues considered by and acted on by the Sunset Commission at its August hearing – some require change in statute, others are directives for management action:

#### **State Bar of Texas – Sunset Staff Recommendations**

**Issue:** *Texas' Attorney Discipline System Lacks Best Practices Needed to Ensure Fair, Effective Regulation to Protect the Public.*

**Adopted:** The Sunset Commission voted to adopt most of the recommendations of the Sunset Staff regarding best practices for the attorney discipline process by authorizing enhanced access to criminal background information and reporting requirements. It would authorize the State Bar to access any criminal background information obtained by the Board of Law Examiners during initial licensure of the attorney. For currently licensed attorneys without information on file with the Board, it would require the State Bar to obtain new fingerprint-based criminal background checks, phased in over a two-year period. Licensed attorneys will be required to report criminal activity and discipline imposed by other jurisdictions to the Office of the Chief Disciplinary Counsel.

**Also adopted:** Reinstate the chief disciplinary counsel's subpoena power during the investigative phase of the attorney discipline process. Require a process and criteria for conducting investigatory hearings to attempt earlier resolution for certain cases. Require a re-evaluation and adjustment of time frames governing the grievance process to ensure workability. Clearly establish the Grievance Referral Program in rule and expand its use to any point in the attorney discipline process. Require comprehensive sanction guidelines in the Texas Rules of Disciplinary Procedure. The Chief Disciplinary Counsel was also directed to more proactively provide assistance to complainants in understanding reasons for complaint dismissal.

**Modified requirements adopted:** Require the Chief Disciplinary Counsel to query the national disciplinary database at regular intervals and to track and report disciplinary case outcomes in greater detail. Require the State Bar to post more information on its website about disciplinary actions taken against attorneys and to post summary statistics and trend information regarding the attorney grievance system on the home page of its website, including but not limited to data on the number of grievances received, their disposition, and the average time for resolution of each step of the grievance process.

**Not adopted:** Require overdraft notifications for attorney trust accounts so that the chief disciplinary counsel has an early warning system for possible misuse of client funds.

**SBOT Sunset Review***Continued from page 10***Issue: *The State Bar Does Not Maximize Informal Dispute Resolution to Most Effectively Resolve Grievances Against Attorneys.***

**Adopted:** The Commission voted to divert minor issues from the formal grievance system to the Client-Attorney Assistance Program for informal dispute resolution and to repeal the requirement to refer dismissed grievances to the Client-Attorney Assistance Program.

**Adopted New Issues: *Create the Committee on Disciplinary Rules and Referenda as a new standing committee of the Bar.*** The Committee shall regularly review the Texas Rules of Disciplinary Conduct and the Texas Rules of Disciplinary Procedure, issue a report to the Supreme Court and the Bar Board at least annually and oversee the initial stages of the rulemaking process. The Committee shall initiate rulemaking or issue a written explanation regarding why it declined to do so within 60 days of designated requests for rulemaking. Referendum ballots must be limited to one subject and proposals printed in the *Texas Register* and the *Texas Bar Journal* for public review and comment – standard practice for rulemaking. All meetings/hearings of the Bar Board and Supreme Court where proposals are deliberated shall be advertised and open to the public. All votes shall be recorded and made public. Proposed modifications to the process would preserve Texas attorney's right to vote in rule referenda and transfer the authority to change fees to the Supreme Court, which already had authority to approve the State Bar's budget.

***Establishment of an Independent Ombudsman Office***

The Commission voted to establish an independent Ombudsman's Office under the Supreme Court to help oversee the attorney grievance system and provide an independent review to help the State identify and correct problems within the Bar's current disciplinary process. Except for the source of the salary, the Ombudsman shall be completely independent from the State Bar, the Board of Directors, the Commission for Lawyer Discipline and the Office of the Chief Disciplinary Counsel. The Ombudsman shall receive and review complaints about the system and attorneys, answer questions from the public and at least annually make recommendations to the State Bar Board and the Supreme Court regarding possible improvements to the system, including ways to improve access to the system and revisions to the grievance form. Some limitations on Ombudsman authority were also included.
